#### **Out District Students**

Acceptance of out-of-district students is a program that spans one school year at a time. Parents/guardians must reapply each spring for the following school year. Please complete an Open Enrollment application at the Lapwai School District Office prior to registration August 13th and 14th. We are located in back of the gymnasium lobby at 404 S. Main Street in Lapwai. Idaho Code also requires districts to charge tuition for out of state students, please contact the district office for additional information. Actual student enrollment maybe be considered before approving an out of district enrollment request. **Elementary (Pre-k-5)** registration is August 13<sup>th</sup> & 14<sup>th</sup> 10:00am-6:00pm both days.

Parents with students entering kindergarten need to bring birth certificate and up-to-date immunizations to registration, this is mandatory to enroll into kindergarten.

**MIDDLE/HIGH (6-12)** registration is August 13<sup>th</sup>& 14<sup>th</sup> 10:00am-6:00pm both days. New students please register on August 15<sup>th</sup>.

### STUDENT DIRECTORY INFORMATION

At times during the school year legitimate requests are made by agencies such as parent groups or armed forces to obtain lists of student's names and addresses. ### **CHILD FIND**

The Lapwai School District would like to take this opportunity to notify our community of Child Find activities. We would like to ensure all children receive the services they need. The school district has a special education screening program to identify and screen all children with suspected disabilities who are residents of the district and who have not graduated from high school. Upon request the school district will screen any resident child who has not graduated high school to determine whether a special education referral is appropriate. When school staff reasonably believes a child is a child with a disability, they refer the child for evaluation by a school district Individualized Education Program (IEP) team.

In addition, if you have a child between the ages of 3-5 the Lapwai School District and Nez Perce Tribe Head Start Program will be providing joint developmental screening in September. Each child's motor, communication, and social skills are observed at various play areas. Each child's hearing is checked and information is provided on vision assessments. The information is used to provide the parent with a profile of their child's current development and to provide suggestions for follow-up activities. The information from the screening is also used to determine whether a child should be evaluated for a suspected disability.

A physician, nurse, psychologist, social worker or administrator of a social agency who reasonably believes a child brought to him or her for services is a child with a disability has a legal duty to report the child to the school district in which the child resides. Before referring the child, the person making the referral must inform the child's parent that the referral will be made.

A referral of a child residing in the Lapwai School District may be sent to Lori Ravet, Special Education Director/School Psychologist at 404 South Main Street, Lapwai, Idaho 83540, or by email
