The Lapwai Guidance Counselor and transition coordinator with support from our College and Career Readiness specialist will continue to collaborate with students in grades 8 through 12 to ensure that all students have access to dual Credit Opportunity, transition coordinator opportunity and portfolio guidance. Lapwai High School's guidance counselor and transition coordinator will collaborate on portfolio management within college credit classes in SD 100 and SD 120.

Local Covid-19 data resulted in a late start in 2021-2021 with a blended learning model and small group instruction in pods of 10. This model continued through March 2021 when we returned to full-day, in-person instruction. Despite these challenges, our schools made excellent progress toward their identified performance targets.

Lapwai Elementary School

ELA: Fifty percent of Lapwai Elementary School students grades K-5 will meet or exceed expected growth in reading (K Letter Sound) fluency as measured by fall 2020 to spring 2021 AIMSweb Benchmark Assessment.

Students scoring at or above the *90th percentile, who do not achieve realistic or ambitious progress on the Spring RCBM assessment, will be counted as having met their fluency goal.

The goal was achieved. Fifty percent of Lapwai Elementary School students grades K-5 will meet or exceed expected growth in reading (K Letter Sound) fluency as measured by fall 2020 to spring 2021 AIMSweb Benchmark Assessment.

MATH: Lapwai Elementary students grades 1-5 who score at/above benchmark will increase by 25% from Fall 2020 to Spring 2021 measured by STAR Math Benchmark Assessment.

The goal was not reached. The number of Lapwai Elementary students grades 1-5 who scored at/above benchmark increased by 22% from Fall 2020 to Spring 2021 as measured by STAR Math Benchmark Assessment.

Lapwai Middle-High School

ELA-READING STAR GOAL: In grades 6th - 12th, 50% of students will grow at least 40 Student Growth Percentile (SGP) points or score above the 50th percentile on the NCE (Normal Curve Equivalent, aka the national average) on the STAR Spring benchmark test.

Goal Met: 57%

MATH STAR GOAL: In grades 6th - 11th, 60% of students will grow at least 40 Student Growth Percentile (SGP) points or score above the 50th percentile on the NCE (Normal Curve Equivalent, aka the national average) on the STAR Spring benchmark test.

Goal Met: 65.89%

Positive Behavioral Interventions and Supports: Behavior expectations will be taught explicitly, modeled, practiced, and positively reinforced with 70% fidelity during the 2020-2021 academic school year AND at least 90% of staff can list 67% of the expectations according to the 1.4 teaching expectations of the Tiered Fidelity PBIS Inventory.
