School Board Minutes  
Regular Meeting  
October 20, 2025

The Board of Trustees of School District #341 met in regular session in the Board Room of the District Office. Trustee Johnson presided over the meeting, calling the meeting to order at 5:00pm. The board then led those in attendance in the Pledge of Allegiance. Roll Call was made, present were Trustees Kipp, Johnson, and Garcia. Trustee Samuels-Allen and Spaulding were absent. Also attending was Superintendent Aiken and Clerk Weeks. There were several people in the audience.

Trustee Kipp moved and Trustee Garcia seconded that the consent agenda be approved as presented. The consent agenda included meeting minutes, payment of bills as presented, budget report, balance sheet, and ASB accounts. A vote was taken and the motion passed.

Principal Wagner said things are going smoothly and there are 90 students in the afterschool program.

Principal Penney highlighted the social studies curriculum that was selected by the committee. They are recommending changing from Discovery Education to McGraw Hill.

Special Education Director Ravet said they have 100 student receiving services and may have at least 10 more soon.

Superintendent Aiken talked about the formation of the Faculty Cabinet.

Light discussion was had about Athletics.
